ADMISSION PROCEDURE :

20 candidates are admitted to the course every year.

Eligibility :

1. An applicant must be a citizen of India.
2. Has completed the age of 17 yrs and be below 30 yrs of age. Relaxation of upper age limit upto 5 yrs shall be permissible for ST, SC and OBC candidates.
3. Has passed the HSSLC or its equivalents.
4. Candidates should be physically and mentally fit.



IMPORTANT POINTS FOR ANM / HW TRAINING CANDIDATES :

Documents to be attached :

- a) 2 passport photocopy (colour)
- b) Attested copy of HSSLC Certificate & Mark sheet.
- c) Attested copy of Mark sheets of HSLC and above.
- d) Church Membership Certificate.
- e) Attested copy of Birth Certificate.

Rejection of Application forms :

- a) Application Forms received after due date.
- b) Incomplete Application Form.

CRITERIA FOR SELECTION :

1. Applicants should submit their application form completely filled in, within the specified time. Late submission of the application form will not be considered.

2. Written test will be conducted on the notified date. All the selected candidate/applicants will be called for Personal Interview on the notified date.

3. The school will provide Admit Card for all the candidates and only those candidates with Admit Card will be allowed to sit inside the Examination Hall.

4. The following documents should be brought along with during the Personal Interview :

a) HSSLC - Original Mark sheet & Certificate.

b) Mark sheets of HSLC and above.

c) Medical Certificate.

d) Migration Certificate/Testimonial Certificate.

e) Application form should bear Office Seal; and if not, the application form will not be considered.

f) It is compulsory for the selected candidates to stay in the hostel.

g) Applicant who wish to join ANM Course should not indulge themselves in alcohol or drugs and any other tobacco products.



DURATION :

The course of study shall be 2 years (academic years) recognized by Indian Nursing Council and the State Nursing Council i.e. Mizoram Nursing Council.

SESSION : October - September* Training (and Classroom Teaching) is conducted according to the Indian Nursing Council guidelines. At the end of each year, Council Exam is conducted by the State i.e. Mizoram Nursing Council.

* Students are exposed to rural areas and urban areas as prescribed by the INC syllabus.
