

February Activity Report of JSS

Introduction:

Key Activities:

Training of Trainers for PM Vishwakarma scheme:

During 1st to 5th February 2024, Training of Trainers was carried out by the assessment agency according to the nomination submitted by JSS Mamit. Training for trainers and assessor was completed for the trade of Barber under Beauty and wellness. J Vanlalbela and Edentharnghaihawma was successfully certified for trainers and assessor under Skill India.

Media Training Organized by Media Division, MSDE:

Directors of all JSS convened for a meeting to discuss and coordinate efforts regarding the Media Training organized by the Media Division of MSDE. This training aimed to enhance the media-related skills of the staff and beneficiaries associated with JSS. Subsequently, social media handles were established on platforms such as Facebook (Jan Shikshan Sansthan Mamit), Instagram (jssmamit), Twitter (JSSMamit).

Inspection for Old Age Home, project under Jal Jivan Mission:

An extensive inspection was conducted under Jal Jeevan Mission on 13th February 2024 based JSS Mamit, as it is one of the branches of MFM to evaluate the suitability and availability of the organization for establishing an old age home, with the primary goal of ensuring alignment with the mission's objectives and operational standards.

Conducting Assessment of Self-employed Tailors under DAY-NULM:

JSS actively engaged in the preparation phase for conducting assessments of self-employed tailors under the Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM). This initiative is pivotal in evaluating the skills and competencies of self-employed individuals within the community. Assessment was conducted on 13th February by Assessment agency approved by NSDC, assessor name Miss Sushma Verma.

PSI visited JSS Mamit:

On February 13, 2024, Population Services International (PSI) along with parent organisation (MFM) conducted a visit to Jan Shikshan Sansthan (JSS) Mamit to assess the current situation and better understand the field. The purpose was to develop strategies to empower the youth of Mamit. Attending the meeting were the Secretary, Joint Village Council of Mamit, President of Sub Headquarters YMA, Mamit, Director of JSS, Project Coordinator of MFM, Mr. Vivek Sharma, Vice President of PSI, and Hardeep Singh Bambrah, Consultant at PSI. Additionally, discussions were held with tailoring students from JSS Mamit to gain insight into the perspectives of the youth and identify existing gaps.

Conducting Assessment on Handloom at Rawpuichhip:

JSS conducted assessments on 21st February related to handloom activities at JSS Sub- Training Centre, Ropuichhip among the beneficiaries. This endeavor is aligned with the broader goal of promoting traditional crafts and empowering artisans engaged in the handloom sector.

Student Orientation for Free Skill Training under DAY-NULM:

On 22nd February 2024, the Orientation for the Students regarding Free Skill Training under DAY-NULM in three trades which are: Baking Technician, Domestic Data entry Operator and Self-employed tailor was held at the JSS Mamit. The Orientation was conducted by Miss Lalrinfeli, Director JSS Mamit. The session aimed to inform and guide prospective students regarding skill training opportunities available in three distinct trades.

Online Meeting with Miss Ellen from LESDE Regarding PM Vishwakarma:

On 26th February 2024, Meeting was held with Miss Ellen Lalnunmawii, State Engagement Coordinator, NSDC regarding the centre readiness for PM Vishwakarma Scheme. It was also discussed the matters pertaining in the preparation process.

Throughout the month, enrolment and training activities continued as usual, reflecting JSS's ongoing commitment to skill development and empowerment within the community.
