#### 1 INTRODUCTION:

#### 2. LOCATION:

MFM School of Nursing is located at Durtlang North. The school is recognized by the Indian Nursing Council and Mizoram Nursing Council.

#### 3. PURPOSE:

The Programme fawned to the health needs of the country, community and individual which will serve as a basis for advanced

study and specialization in nursing. It will assist nurses in their personal and professional development, so that they can make their maximum contribution to the society, as individual, citizens and nurses.

#### 4. AIMS & OBJECTIVES:

#### Note:

- 1. Fees once paid are not refundable.
- 2. Course Fee/monthly fee must be paid well in time, failing which, a late fee of Rs. 20/- per day will be charged as fine
  - Monthly fee must be paid on or before 15th day of every month.
- 3. Student once admitted, cannot leave / quit the institution in the middle of the course whatsoever the case might be. Such students must pay up all the course fees.
- 4. The fees and other charges are subject to revision from time to time

# 6. ADMISSION PROCEDURE:

20 Candidates are admitted to the course each year.

#### 7. ELIGIBILITY:

- 1. An applicant must be a citizen of India.
- 2. Has completed the age of 17 yrs and be below 30 yrs of age. Relaxation of upper age limit up to 5 yrs shall be permissible for ST, SC and OBC candidates.
- 3. Has passed the HSSLC or its equivalents.
- 4. A Christian Candidate should be full member of his/her Church.
- 5. Candidates should be physically and mentally fit.

# 8. IMPORTANT POINTS FOR ANM / HW TRAINING CANDIDATES:

#### 8.1. Documents to be attached:

- a) Passport photocopy (colour).
- b) Attested copy of HSSLC Certificate & Marksheet.
- c) Attested copy of HSLC Certificate & Marksheet.
- d) Attested copy of Birth Certificate.

# 8.2. Rejection of Application forms:

- a) Application Forms received after due date.
- b) Incomplete Application Form.

# 9. CRITERIA FOR SELECTION:

- 1. Applicants should submit their application form completely filled in, within the specified time. Late submission of the application form will not be considered.
- 2. Written test will be conducted on the notified date. All the selected candidate/applicants will be called for Personal Interview on the notified date.

- 3. The school will provide Admit Card for all the Candidates and only those candidates with Admit Card will be allowed to sit inside the Examination Hall.
- 4. The following documents should be brought along with during the Personal Interview:
  - a) HSSLC Original Mark sheet & Certificate.
  - b) Mark sheets of HSLC and above.
  - c) Medical Certificate.
  - d) Migration Certificate/Testimonial Certificate.
  - e) Application form should bear Office Seal and if not, the application form will not be considered.
  - f) It is compulsory for the selected candidates to stay in the hostel.
  - g) Applicant who wish to join ANM Course should not indulge themselves in alcohol or drugs and any other tobacco products.

#### 10. DURATION:

The course of study shall be 2 years (academic years). Recognized by Indian Nursing Council and the State Nursing Council i.e. Mizoram Nursing Council.

#### 11. SESSION:

October - September

- Training (and Classroom Teaching) is conducted according to the Indian Nursing Council guidelines. At the end of each year, Council Exam is conducted by the State i.e. Mizoram Nursing Council.
- Students are exposed to rural areas and urban areas as prescribed by the INC syllabus.

#### 13. GUIDELINES FOR INTERNSHIP:

- The ANM students (in a group of 4-5) will be posted in the Sub-Centre / Primary Health Centre with a regular ANM for 1 month / 4 Weeks for supervised independent practice in the community which should be residential.
- 2. The students would participate in all National Health &Family Welfare programs during their clinical experience.
- 3. At least 80% of all the clinical requirements should be completed before appearing for the final (second year) examination.
- 4. The Principal will certify for each student that she has under gone successfully the internship program, completed 100 % of clinical requirements and acquired the requisite the competencies as listed in the syllabus before the award certificate / diploma by the Mizoram Nursing the Council/Examination Board.
- 5. The cashbook and competency record book should completed and signed by the competent authority of the School before appearing for the second year practical examination.

#### 14. EXAMINATION:

The School conducted PTS examination after three (3) months of starting the course and Institutional Exam twice a year. Selection Examination will be conducted before appearing the Council (MNC) exam in the month of July. The state i.e. Mizoram Nursing Council conducts the Final Exam in the Month of September.

# 14.1. Eligibility for Admission to MNC Examination:

- 1. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.
- 2. A candidate must have 100% attendance in each of the practical areas before the award of completion certificate / diploma by the Mizoram Nursing Council Examination Board.
- 3. On Completion of Practical experience, records to be signed by the tutor and countersigned by the principal.
- 4. The examination for the 2nd year should happen at the end of the year. A certificate of completion of internship by each student should be provided by the Principal before entering for the examination.

14.3 Grading and Certification:

Distinction shall be in aggregate = 75 %

First Division = 70% & Above Second Division = 60% - 69%Third Division = 50% - 59%

Certificate will be issued on successful completion of training requirement. Qualified ANMs have to be registered by the Mizoram Nursing Council under the provision of MNC and INC Act as ANMs, before joining services as a qualified Female/Male Health Worker and to practice as ANM.

#### 15. FACILITIES FOR STUDENTS:

#### 15.1 CLINICAL:

Student obtain general clinical experience from Civil Hospital, Aizawl with a bed strength of 300 and Synod Hospital Durtlang with a bed strength of 300.

#### 15.2. HOSTEL:

The school provides all the necessary facilities to all the students. Hostel stay is compulsory for all students.

# Items required on joining the Hostel:

- 1. Mattress & Blankets
- 2. Bed sheets, pillow, bath towel, pillow covers, handkerchief and mosquito net.
- 3. Personal clothing and toilet articles.
- 4. Pen, ruler, eraser, papers and Bound Exercise Book (1doz). (To be provided by the institution).
- 5. One wrist watch with second hand.
- 6. One trunk box with lock & key.
- 7. Cutlery, plate, cup, tiffin carrier & drinking bottle.
- 8. Holy Bible
- 9. Plastic bucket, Mug, one two celled torch, One pair of black shoes and other pair of sandals.
- 10. Biology Practical Book
- 11. JF Dictionary
- Hostel uniform is provided to all students.
- Classroom and Clinical Uniform also be borned by the Students.
- ❖ Above these, cost of Text Books will be borned by the Student themselves and be cleared after Admission.

#### 15.3. MEDICAL:

Health record of every student is maintained by the institution.

#### 15.4. TRANSPORT:

The school owns a 25 seater bus for transportation of students to hostels, hospitals and community postings.

#### 15.5. LIBRARY:

There is a well-equipped library with all the latest Nursing and Medical Books and relevant Journals, Magazines and newspapers.

#### 15.6. SPIRITUAL ASPECTS:

The Evangelical Nurses Fellowship (ENF) conduct ENF worship service every first Friday of the month in the school premises and the second year student attend ENF students camping every year. The institution organise Gospel Meeting for the students every year in the month of December.

# 15.7. CO-CURRICULAR ACTIVITIES:

The students take active role in Students Nurses Association (SNA), Evangelical Nurses Fellowship (ENF) and other various professional activities.

## 15.8. SOCIAL WORK:

The Hostel Warden arranges Social Work for all the students every Saturday and students are expected to get themselves engaged in these activities.

# 15.9. **GAMES & SPORTS**:

Facilities for Indoor Games like Carrom Board, Chinese Checker, T.T., Television, etc are available in the Hostel. The SNA

organize various games & sports once in a year for its member. The students participated actively in the various sports and games organized by the State SNA.

#### 16. WITHDRAWAL FROM SCHOOL:

The school reserves the right to terminate a candidate whose work or conduct is not found satisfactory or for any other cause during the period of training or service.

#### 17. SCHOOL AND HOSTEL RULES & REGULATIONS:

# 1. Outing:

- a) Students are not allowed to go outside the school premises during class and clinical duty hours without the permission of the Warden/ School authority.
- b) Students will be permitted Day Out as and when required under the permission of the Warden and should return to the hostel on the specified time.
- c) Students are not allowed to have night out unless given permission during their period of training.

#### 2. Leave:

- a) a) Students are given sick leave (10 days per year) on the permission of the Principal. Students who take leave on medical ground should produce the medical certificate along with the leave application.
- b) Information will be given to Parents/Guardian in case of seriously ill students.
- c) Students must take permission before taking any leave.

#### 3. Phone & its Accessories:

Students are not allowed to bring mobile phone and its accessories within the school premises. Necessary action will be taken by the school authority in case of violation.

#### 4. Substance Abuse:

Strict action (suspend/termination) will be taken if any students are found indulging in any kind of drugs or alcohol. Abusive substances should not be taken inside the school premises and clinical area.

# 5. Truancy:

Strict action (suspend/termination) will be taken by the school authority in case of truancy from hostel or school.

The School Management Committee/Managing Board reserved the right to change the Hostel and School Rules and Regulations from time to time.

## 18. CONCLUSION:

The School has its own set of Rules & Regulations to which the students are required to abide with. Any students found violating the existing Rules and Regulations are bound to penalty whatsoever the cause of violations.

The faculty believes in the need of all round development of each student. To achieve this, the faculty helps the students in meeting their physical, mental and especially spiritual needs.

## ANTI-RAGGING MEASURES

In pursuance of the AICTE (Prevention and Prohibition in Technical Institutions, Universities including Deemed to be Universities imparting Technical Education) Regulations 1990, and in order to provide for the

healthy development Physically and Psychologically of all students, the Governing authority of the MFM School of Nursing (ANM) Durtlang North, Aizawl, Mizoram not only disallowed any student or students but totally prohibited:-

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effects of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in row or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in ordinary course do and which has effect of causing a sense of shame or foment or embarrassment so as to adversely effect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or fresher.
- e) Exploiting the services of a fresher or any other student for completing academic tasks assigned to an individual or a group of students;
- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g) Any act of physical abuse including all variants of it :-Sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures causing bodily harm or any other danger to health or person.
- h) Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively

- participating in the discomfiture to fresher or any other student.
- Any act that effect the mental health and self- confidence i) of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student. If anyone is found guilty of the offence of any type of ragging mentioned at (a) to (i) and/or abetting any such kind of ragging avert or overt is liable to debarring from appearing in any test/examination or other evaluation process, withholding results, debarring from representing the Institution in any Meet, Tournament, Youth Festival, expulsion from Hostel and/or Institution and debarring from admission to any other Institutions, suspension from attending classes. withholding/ withdrawing scholarship/fellowship and other benefits, rustication from the Institution for a period ranging from 1 to 4 Semester. When the person committing or abetting the crime of ragging are not identified, the Authority shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
